**ANNEXURE-I** 

#### **INSTRUCTIONS TO BIDDERS**

- Sealed Tenders' are invited by Director, National Institute of Public Cooperation & Child Development hereinafter referred as NIPCCD intends to identify a firm for providing Service of Maintenance of Air Conditioners & Water Coolers/Dispensers etc.
- 2. The bidders must be registered with appropriate authorities to provide above-mentioned services. A copy of valid licence/permission may also be enclosed.
- 3. Bidders would need to describe their capabilities with their bid which would include a good track record, and demonstrated capability to undertake the above mentioned services.
- 4. Bidders should attach its last three years' balance sheets duly certified by a Chartered Accountant along with a copy of depositing of Service Tax Registration and copy of **PAN** Card. These are mandatory and in the absence of any of these, the tender shall be rejected on the spot.
- 5.Tenders should be accompanied by earnest money of Rs.15,000/- in the form of A/c payee bank demand draft in favour of Director, National Institute of Public Cooperation and Child Development and payable at New Delhi failing which tender shall not be considered.
- 6. The sealed tender duly super-scribed "Tender for Service of Maintenance of Air Conditioners & Water Coolers/Dispensers etc. of the Institute should be dropped in the Tender Box in Room No.107 at first floor of the Institute at 5, Siri Institutional Area, Hauz Khas, New Delhi-110016 not later than \_\_\_\_\_on \_\_\_\_\_ Bids received after the prescribed date and time shall not be considered.

In case of Deposit – at Call, it should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the bidder.

9. Notwithstanding the above, Director of the Institute shall have right to reject any tender without giving any reasons thereof.

**ANNEXURE-II** 

### TERMS AND CONDITION FOR MAINTENANCE AIR CONDITIONERS & WATER COOLERS/DISPENSER ETC.

The institute is an autonomous body functioning under the aegis of Ministry of women & Child Development, Government of India. The Institute s has window / Split s type air conditioners, water coolers and dispenser of deferent makes. Rates are invited for annual maintenance of the above items, from reputed firms having experience in this field. The terms and conditions of the contract will be as under:

- 1. The agency will deposit a security of Rs. 15,000/- with the institute which will not carry any interest. The security amount will be deposited within 15 days' time from date of award of work in the form of FDR in favour of Director NIPCCD.
- 2. The agency will maintain the air conditioner/water coolers in good condition to provide uninterrupted service.
- 3. The engineers/ mechanic of the agency will attend the complaint to repair the machine working within two hours of making call by Institute.
- 4. The agency will provide the replacement/standby Air Conditioners in case the Air Conditioners under AMC is to be taken for repair in the workshop outside NIPCCD. The repairs will be undertaken within 24 hours or depending on defect, maximum 36 hours.
- 5. The agency during the contract period will supply replace air filter, compressor, electrical accessories, fan mooter, gas charging, control known, cabinet, sheet metal panels, evaporator and condenser coil, front grill, painting, and it accessories and any change in installation free of charges at this own cost of expenses. The parts removed for replacement will be the property of the institute. Thus the rates quoted are inclusive maintenance of air conditioners/ water coolers including, repair/replacement of parts, compressor etc. and will be valid for a period of one year.
- 6. The rates quoted by agency are including local conveyance or cartage charges or any other charges for repair/maintenance of the air conditioner/ water coolers.
- 7. The Institute will pay 50% of consideration in advance (as per provision under GFR 2017) after signing of the agreement for AMC. On expiry of six month and receipt of report for satisfactory service provided by the firm is

- given by as authorized officer, the balance 50% advance will be released to the agency.
- 8. The Institute will be free discontinuing the contract after giving a week s notice in writing.
- 9. The agency will attend to maintenance of air conditioners/water coolers during normal working hour, but urgent work will be attended to beyond normal working hours and during holidays with the proper permission of the institute, within the premises of the Institute.
- 10.Periodical routine checking and serving of air conditioners/water coolers will be done by the agency every month by the tenth working day each and additionally as and when the complaint is received.
- 11. The agreement is not transferable.
- 12. The equipment's taken by the agency to their workshop will be entirely at the risk off the agency for loss by theft, fire or any other reason.
- 13. The Institute will not be responsible for any injury to the workmen arising out the service/ repairs of the equipment's at the premises of the Institute.
- 14.All dispute and differences arising out the contract shall be referred to an arbitrator appointed by the Director of the Institute.
- 15.In case of more than 24 hours of downtime of ACs, the agency will provide a replacement so that the work of the Institute does not suffer in the absence of air conditioners/ water coolers.
- 16.If the firm falls to carry out repairs within 24 hours, to the satisfaction of the user, a penalty of Rs.500/- (Rupees Five hundred per day) thereof will be charged for delay beyond the one day till such times AC/ Accessory are repaired. The source engineer after successfully attending the call.
- 17.Parts replaced by the agency will be genuine and as per specification of the equipment's for ensuing smooth functioning.
- 18. The Institute reserves the right to forfeit the security amount of agency in case of violation of any terms and condition of contract.
- 19. The AMC is renewable for one year after the expiry of present AMC on the same terms and conditions.
