3. After final admission, a candidate will be allowed to withdraw his/her admission **upto 15 calendar days** from the **date on which he/she takes admission**. An application for withdrawal of admission should reach SPNIWCD, Regional Centre, Mohali within 15 days after the admission i.e. on or **before 30<sup>th</sup> June, 2026**. In such case the Institute will refund the admission amount **after deduction of 10%** from the full amount towards withdrawal charges. If the candidate withdraws the candidature after commencement of the course i.e. **01<sup>st</sup> July, 2026 onward** or **anytime during the course** they will have to deposit an amount of **Rs.60,000/-, which is over and above the fee which the candidate has deposited at the time of the admission**.
4. In Case any candidate fails to pay the fee amount within the **stipulated time, his/her seat will be forfeited and offered to the next candidate**.
5. Declaration form sent on email of each candidate is compulsory to be submitted, duly signed with date. Also, declaration form/s along with self-attested copies sought through email must reach office in original/hard-copies for finalization of candidature of admission.
